I AGREE that I choose to participate voluntarily in the Competition with my horse as rider, driver, handler, lessee, owner, agent, coach/trainer, or as parent or guardian of a junior exhibitor. I am Fully aware and acknowledge that horse sports and the Competition involved inherent dangerous risks of accident, loss, and serious bodily injury included broken bones, head injuries, trauma, pain, suffering, or death (“Harm”)

I AGREE to release the Palouse Empire Appaloosa Club and the competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm was caused by me or my horse to others, even if the Harm results, directly or indirectly, from the negligence of the Palouse Empire Appaloosa Club or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of Washington State Horsemen or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) Palouse Empire Appaloosa Club and the Competition and to hold them harmless with respect to claims for Harm to be or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.

I have read the Washington State Horsemen rules about protective equipment and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that the Palouse Empire Appaloosa Club strongly encourages me to do so while WARNING that protective equipment cannot guard against all injuries.

If I am a parent or guardian of a junior exhibitor, I consent to the child’s participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this release on the child’s behalf.

I AGREE that Washington State Horsemen and “Competition” as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers, and affiliated organizations.
